Booking Form means this form

Le Domestique Tours means Le Domestique Limited trading as Le Domestique Tours and **Us, Our** or **We** shall mean the same

Le Domestique Tours Bank Account means Le Domestique Limited, Natwest Bank Plc, Account No. 56117795, Sort Code 60-21-34.

Le Domestique Tours Paypal Account means the Le Domestique Tours paypal account info@ledomestiquetours.co.uk (please note that payment via paypal requires a 4% surcharge)

Tour means the trip booked by You with Le Domestique Tours whether supported, unsupported or otherwise, as specified on Our website

Tour Balance means the Tour Cost minus the Tour Deposit

Tour Cost means the amount notified by Le Domestique Tours to You for the cost of the Tour

Tour Deposit means £300 or such higher amount as notified by Le Domestique Tours to You

You means the person making the booking and **Your** shall mean in respect of You

Bookings, deposits, cancellations and refunds

Once We have confirmed availability for a Tour, all You need to do is complete this Booking Form and send it to Us by email PDF to info@ledomestiquetours.co.uk and arrange for payment of Your Tour

Deposit via bank transfer to the Le Domestique Tours Bank Account or via the Le Domestique Tours Paypal Account. Please ensure that You identify Your payment with a message such as "Deposit Mr Smith".

Accommodation is provided on a shared room basis (with a maximum of one other same sex person). We may be able to offer sole occupancy rooms for an additional charge.

We will acknowledge receipt of the Booking Form and the Tour Deposit via email to You.

The Tour Balance is payable 12 weeks prior to Your arrival date unless We have agreed otherwise with You in writing. Unless We agree otherwise with You in writing, We reserve the right to charge an additional administrative charge of £20 (in order to reimburse Our costs of pursuing such payment) in addition to the Tour Balance, or to cancel Your Tour and resell Your place.

If You are unable to attend Your Tour and cancel within 3 months of Your arrival date then You remain liable for the full amount of the Tour Cost.

If You cancel Your Tour in writing more than 3 months prior to Your arrival date You will be entitled to a refund of any monies paid by You with the exception of the Tour Deposit which is non-refundable.

If You are travelling in a group and a member of the group cancels their place, then We reserve the right to resell their place and may require You to share a room with any person that takes their place.

If for any reason We are forced to cancel Your Tour We will offer You an alternative Tour or will offer a full refund. We do not accept liability for any travel or other costs which You may have incurred.

Airport transfer and support services

We will notify You of Our recommended flight times and will arrange for Our airport shuttle service to meet You at the relevant airport at the appropriate time. While We will make reasonable efforts to accommodate any deviations from these arrangements (for example for delayed flights or where flights are missed), We reserve the right to charge an additional amount to cover any additional costs incurred by Us or to insist that You make Your own arrangements to get from the airport to Us. We will notify You of appropriate options in this regard.

Le Domestique Tours does not accept any responsibility for injury loss or damage to You or Your property which is incurred or caused whilst travelling in any vehicle provided by Le Domestique Tours, nor do We accept liability in respect of any delay in activities caused by a breakdown or other problem with such vehicles.

Liability of Le Domestique Tours

When We supply ancillary services, which include any services supplied by a third party, We do not give any warranty or guarantee as to their quality, fitness for purpose or otherwise but shall, where possible, assign to You the benefit of any warranty, guarantee or indemnity given by the person supplying those services.

We shall have no liability to You for any loss, damage, costs or expenses or other claims for compensation arising from any instructions supplied by You which are incomplete, incorrect, illegible, out of sequence or in the wrong order or form, or arising from Your late arrival, non-arrival or any other fault of Yours.

Except in respect of death or personal injury caused by the gross negligence of Le Domestique Tours, or as expressly provided in this Booking Form, We shall not be liable to You by reason of any innocent misrepresentation or any implied warranty, condition or other term, or any duty at common law, for any loss of profit, opportunity or any indirect, special or consequential loss, damage, costs, expenses or other claims (however caused) which arise out of or in connection with the provision of any Tour (including any delay or failure to provide it), so however that, the entire liability of Le Domestique Tours under or in connection with this Booking Form shall be limited in maximum to the amount of the Tour Cost.

Le Domestique Tours is not responsible for any act or omission of Yours which results in the death, personal injury or loss of, or damage to the property of any other client.

Your obligations

You accept that cycling and triathlon are inherently dangerous activities and accept full responsibility for Your actions and their consequences.

Insurance for medical emergency, including in any such event, repatriation, loss of earnings, or resulting cost of care; loss, damage or theft to/of Your property (including Your bicycle or any other equipment); liability incurred to third parties; and against costs You may incur in the event of cancellation or curtailment of the Tour or Your participation in it, is not included in the cost of the Tour.

It is a condition of booking that You are covered by comprehensive travel insurance and do not travel or participate in any activity against medical advice. You should organise such insurance immediately and ensure that it covers You for the duration of Your Tour. We reserve the right to ask for copies of such policy documents prior to Your travel and reserve the right to refuse entry to Your Tour if You are unable to provide details of Your cover.

You agree that You may be photographed in the course of the Tour for the purpose of Our future publicity and that any written comments You make about the Tour or Us may be published by Us and referenced to You.

You agree to abide by any reasonable directions (especially any given on account of health and safety), given by Us or Our representatives in the course of the Tour.

You agree to behave in a reasonable and responsible manner and, in particular that You will do nothing which might endanger the health and safety of any person involved in the Tour or which might result in

personal injury to any person or loss of or damage to property belonging to Us, Our representatives or other clients.

You agree to abide by the "house rules" during Your stay with Us, which include acting considerately to other clients and members of Our staff and treating the accommodation with an appropriate level of care.

You agree that it is Your responsibility to carry any valid passport or visa, necessary for the Tour and, in any event even for domestic tours, always to carry some official means of photographic identification, such as a valid driving licence.

You agree to inform Us of any special requests at the time of booking. While We will make reasonable efforts to comply with such requests, We cannot guarantee that they will be met. Furthermore, We will have no liability to You if such requirements are not met.

You agree to settle directly with the seller or provider, and prior to departure, any expenses accrued for goods and or services, over and above the items included as part of the Tour. Any expenses not settled before departure are payable on Your return home, and may be subject to an administration fee of £30.

We reserve the right to demand to terminate Your Tour if You fail to adhere to the above obligations.

Children

Unfortunately, Le Domestique Tours is unable to accept bookings from people that are under the age of 18, unless they are accompanied by an appropriate adult who accepts full responsibility for such person for the duration of their stay and in particular during riding.

Itineraries

While We will make every effort to ensure that the Tour follows the itineraries previously notified by Us either via Our website or via email, You accept that changes may need to be made due to adverse weather conditions, road closures or otherwise. We accept no responsibility or liability in respect of any such changes.

Severability and waiver

If any of these terms or conditions is at any time held by any jurisdiction to be void, invalid or unenforceable, then it shall be treated as changed or reduced, only to the extent minimally necessary to bring it within the laws of that jurisdiction and to prevent it from being void and it shall be binding in that changed or reduced form. Subject to that, each provision shall be interpreted as independent and severable from each other paragraph and therefore separately enforceable.

No delay by Le Domestique Tours in exercising any right, power or provision hereunder shall operate as a waiver of the exercise of any right at a future time.

Entire understanding

This Booking Form contains the entire agreement between the parties and supersedes all previous agreements and understandings between the parties. Each party acknowledges that, in entering into this agreement, he or she does not rely on any representation, warranty or other term not forming part of this agreement, including by reference.

Dispute resolution

In the event of a dispute arising out of or in connection with this Booking Form, the parties undertake to attempt to settle the dispute by engaging in good faith negotiations with the other before commencing litigation.

Jurisdiction

This Booking Form shall be interpreted according to the Laws of England and the parties hereby agree to submit to the exclusive jurisdiction of the English courts.
